Guidance to Tier Award Program (TAP) for 4.B and 4.C Applicants

As part of the State Opioid Response Tier Award Program, there are two tracks of opportunities for the 4.B and 4.C award. One track is for treatment providers as defined below and a second track of opportunities is for community-based organizations as defined below. Applicants cannot apply for both tracks and must choose an opportunity that aligns with the eligibility criteria detailed below.

This may require adoption and inclusion of client surveys, like the Multidimensional Inventory of Recovery Capital (MIRC) or the Brief Assessment of Recovery Capital (BARC-10), that can be aggregated and reported to DSAMH regularly to document changes.

Example one: If a treatment provider were to propose to expand access only through the hiring of an additional MOUD prescriber, the budget should only reflect the efforts and costs to hire and train the additional prescriber but not the salary of the prescriber who will be providing a billable service. This type of project would not likely exceed \$50,000 in the requested budget. Example two: If a treatment provider were to expand access by hiring an additional MOUD prescriber, expanding facility hours to better meet the needs of the population and hiring a peer to support the individuals seen by the provider, more level of effort and expense would be incurred than in example one. This project would likely exceed \$150,000 in the requested budget depending upon the details of the expansion of access. Note: Please be advised that these examples are meant to demonstrate differences in potential funding award amounts and not suggestions or a guarantee of the project's funding as described.	 <i>Example one:</i> If a domestic violence (DV) agency were to propose a cross-collaboration initiative with SUD treatment providers that included four collaborative working sessions to provide guidance and training to the DV counselors on best practices for working with individuals with SUD and conversely, the DV counselors provide training to the peers on the best practices for engaging people who have an SUD and have or are currently experiencing intimate partner violence (IPV). This project would not likely exceed \$75,000 in the requested budget. <i>Example two:</i> A domestic violence (DV) agency could propose to build a program specifically for participants who are struggling with OUD/STUD addiction or in recovery as part of their programming. As part of their program, they propose to: Hire two certified peer specialists with experience in SUD Train the two certified peer specialists to become DV counselors and engage with participants monthly to demonstrate impact Develop/deliver trainings to local SUD treatment providers on best practices in working with people experiencing IPV. This project would likely exceed \$150,000 in the requested budget depending upon the details of the program.

Future, specialized, multi-year, TAP opportunities under SOR 4.0

Please be advised that DSAMH plans to release additional specialized opportunities under TAP by Q2 2025. The Multi-Year Targeted Projects (MYTP) will be specialized opportunities to design and implement specific and complex interventions over a period of 2.5 years, with significant design and technical assistance support from the state. Anticipated funding will support two full years of project implementation after design/approval and are equal in annual value to the TAP 4.B and 4.C tiers. Applicants for these opportunities must have successfully implemented a HEAP or TAP project with DSAMH previously. DSAMH anticipates awarding between 1-4 awards for a targeted cohort of projects depending upon the quantity and quality of applications. Additional details will be released later this fall.
